CITY ORDINANCE NO. 30 Series of 2024

AN ORDINANCE DECLARING THE CITY OF SAN JUAN, METRO MANILA UNDER A STATE OF CALAMITY DUE TO THE HEAVY RAINS AND WIDESPREAD FLOODING IN VARIOUS BARANGAYS OF THE CITY BROUGHT ABOUT BY THE EFFECTS OF TYPHOON CARINA AND THE ENHANCED SOUTHWEST MONSOON

WHEREAS, Section 16 of the Local Government Code states that it is the duty of every Local Government Unit to promote the health and safety of the people within its territorial jurisdiction, and the public in general;

WHEREAS, the Department of the Interior and Local Government (DILG) issued a Memorandum dated July 24, 2024, on the mandatory forced evacuation of communities in high-risk areas due to the continuous heavy rains brought by the Southwest Monsoon enhanced by Typhoon Carina;

WHEREAS, on July 24, 2024, the Metro Manila Council issued a Resolution fully supporting the declaration of State of Calamity in Metropolitan Manila and encouraging residents of Metro Manila to observe highest degree of care and vigilance;

WHEREAS, in adopting the aforementioned Proclamation as well as the findings of the National Disaster Risk Reduction and Management Council, the Sangguniang Panlungsod of the City of San Juan is empowered, through R.A. 10121 otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010, to declare a state of calamity upon the recommendation of the LDRRMC;

WHEREAS, the heavy rains and widespread flooding within the National Capital Region warrants the declaration of State of Calamity in the City of San Juan;

WHEREAS, as of July 24, 2024, large parts of the low-lying cities in Metro Manila are submerged in floodwaters, noting that 70 percent of areas in Navotas City are flooded; 80 percent in Malabon City; and 60 percent in Valenzuela City and other neighboring cities of the City of San Juan;

WHEREAS, as per the report of the City Social Welfare and Development Office (CSWDO), 70 percent of areas or 771 families with 2,940 individuals were severely affected by the effects of the heavy rains and widespread flood in the City of San Juan;

WHEREAS, as of July 24, 2024, the City of San Juan accounted barangays severely affected by flooding brought about by the effects of Typhoon Carina and the enhanced southwest monsoon namely:

WHEREAS, the City Disaster Risk Reduction and Management Council (CDRRMC) issued CDRRMC Resolution No. 10, Series of 2024 entitled: "A Resolution Recommending to the Sangguniang Panlungsod of San Juan for the declaration of State of Calamity due to the heavy rains and widespread flooding in various barangays of the City brought about by the effects of Super Typhoon "Carina" and the enhanced southwest monsoon";

WHEREAS, the Sangguniang Panlungsod, in response to the present situation of calamitous magnitude and upon consultation with the Local Chief Executive, Mayor Francisco Javier M. Zamora, the City Disaster Risk Reduction and Management Council (CDRRMC), and other concerned agencies and offices, has decided to declare the entire City of San Juan under a State of Calamity in order to access the necessary funds to augment the effects of Typhoon Carina and the enhanced Southwest Monsoon.

NOW THEREFORE, BE IT ORDAINED AS IT IS HEREBY ORDAINED, by virtue of the powers vested in the Sangguniang Panlungsod of the City of San Juan, Metro Manila, in a special session duly called and assembled, to declare the entire City of San Juan under a STATE OF CALAMITY due to the calamitous effects of Typhoon Carina and the enhanced Southwest Monsoon in the City effective immediately, and henceforth the Local Chief Executive, Mayor Francisco Javier M. Zamora, is hereby authorized to disburse and use thirty percent (30%) Quick Response Fund from the Local Disaster Risk Reduction and Management Fund (LDRRMF) to address the effects of heavy rains and flooding brought about by the effects of Typhoon Carina and the enhanced Southwest Monsoon for the provision of emergency services and supplies and public assistance during or immediately in order to save more lives, reduce negative health impacts, ensure safety and meet the basic subsistence needs of the people affected. All other powers, duties and responsibilities necessary and essential to arrest the effects of Typhoon Carina and the enhanced Southwest Monsoon are likewise delegated to the Local Chief Executive.

ORDAINED FURTHER, that this Ordinance shall take effect immediately upon its approval.

ORDAINED FURTHERMORE, that the authority, issuance and approval hereof is subject to and conditioned upon full compliance to all existing laws, circulars, rules and regulations.

ORDAINED FINALLY, to furnish all government offices and agencies concerned with copies of this Ordinance
