**b) Ante - Mortem Inspection Fee** - For the inspection of livestock/poultry prior to slaughter/dressing to determine presence of disease/abnormal conditions.

Swine	3.00
Goat/Sheep/Deer	1.50

**c.) Post –Mortem Fees**

For the inspection of the carcass and the edible of all animal/poultry slaughtered/dressed to detect the presence of lesions and abnormalities.

Per Kilo of meat and poultry	P 0.25
Post Mortem Fees inside the slaughterhouse	Hogs P 11.25 per head

**d.) Registration Fees**

Registration Fees of Slaughterhouses, Poultry Dressing Plants, Meat Processing Plants, Meat Cold Storage, Meat and Meat Delivery Vans; for the issuance of Certificate of Registration to public and/ or private slaughterhouses, poultry, dressing plants, meat processing plants, meat cold storage, and meat conveyance after having been evaluated and classified for purposes of standardization.

**e.) Inspection fees for meat and meat products** – Inspection fees for meat and meat products whether fresh, frozen or airtight containers, imported or for export;

Poultry	P .045 per head
Choice Meat Cuts (Pork, Beef) – Import	P 0.50 per kg
Manufacturing Grade Meat Cuts (Pork, Beef) – import	P 0.25 per kg
Poultry (Chicken, Turkey, Duck, etc.)- Import	P 0.50 per kg
Edible Offal (Liver, Turkey, Heart, Spleen, Tail, etc.)	P 0.25 per kg
